We invite you to the Annual Meeting of the Membership of Center for Spiritual Living, Greater Las Vegas, and we welcome your active participation as a member. The agenda for the meeting includes the election of candidates to the Leadership Council, ratification of Bylaw changes, a Financial Report, a “State of the Center” message, and a look ahead.

Included with this notice are the written minutes of last year’s Annual Meeting and a copy of the proposed Bylaw amendments. Voting to approve all items will occur via an electronic ballot. The bylaw amendments relate to:

- the change of our principal office/address
- conducting our affairs/operations virtually
- mission statement
- number of members on the leadership council
- the removal of the need for a corporate seal
- terminology changes

The slate of Leadership Council candidates will be announced via email, on our website, and during Sunday service announcements in the weeks prior to the Annual Meeting.

The ballot must be received by the council no later than Thursday, September 16, 2021 at 3:00 PM Pacific Time in order to be valid for the election.
