OFFICIAL NOTICE TO ALL MEMBERS

Annual Membership Meeting-**DATE CHANGE**

Saturday, November 7, 2020 - Zoom Meeting Opens at 9:30 AM

Meeting will be held virtually, and called to order at 10:00AM

Dear Member,

Due to an unforeseen mailing delay, the 21 day notice requirement for an Annual Meeting was not met in our prior letter. To allow for the proper notice, we have elected to postpone the Annual Meeting until Saturday, November 7, 2020. This letter shall serve as the proper required notice.

We invite you to the Annual Meeting of the Membership of Center for Spiritual Living, Greater Las Vegas, and we welcome your active participation as a member. The agenda for the meeting includes the election of candidates to the Leadership Council, ratification of Bylaw changes, a Financial Report, a "State of the Center" message, and a look ahead.

Included with this notice are the **corrected** written minutes of last year's Annual Meeting, and you have already received a copy of the proposed Bylaw amendments in our prior letter. You will be asked to approve both during this year's Meeting and vote. The bylaw amendments relate to conducting our affairs virtually and will allow for the option of virtual meetings and/or voting if the Leadership Council deems it necessary. If you have any corrections for the 2019 minutes or bylaw amendments, please submit them in writing to council@cslglv.org no later than Friday, October 30, 2020.

We do allow for absentee voting for Leadership Council candidate elections only. As that rule dictates, there are "valid reasons" for missing the Annual Meeting. If any of these reasons apply to you, email council@cslglv.org to request an absentee ballot:

- 1) Scheduled to work
- 2) Planned vacation or other travel out of town
- 3) Medical procedure and/or recuperation

The ballot must be returned to the office no later than Friday, October 30, 2020 at 11:30 a.m. in order to be valid for the election.

Meeting Place: The Annual Meeting will be held virtually via Zoom from 10:00 AM to 11:30 AM. Drive-up voting will occur the same day at 1420 E. Harmon Ave. Las Vegas, NV 89119.

Volunteers will be available to receive your ballot between the hours of 12:00 PM and 1:30 PM. Voting will close at 1:30 PM. No late ballots will be accepted. Ballots and pens will be provided. Please bring your photo ID in case identification is needed. Your ballot number will be used to track your vote. All votes will be submitted confidentially and reported to the final voting numbers. It is important to understand that you must attend the Annual Meeting in order to be

eligible to approve bylaw amendments. Candidate elections are allowed via absentee ballot as stated above. Roll call will be taken at the beginning of the Zoom Annual Meeting.

If you do not have a device with a camera, you may email council@cslglv.org for join-by-phone instructions.

The virtual Annual Meeting will be broadcast in the sanctuary. We will have 25 spaces available to in-person attendees on a first-come, first-served basis. These spaces will be set up in the sanctuary in accordance with social distancing requirements. As per State policy, please wear a mask while on the premises. Masks will also be made available for those who do not have one. Attendance in the sanctuary is by reservation only. You must reserve your seat in advance by emailing council@cslglv.org prior to October 23, with your name, address, phone number and the names of everyone in your party. The meeting is for members only. Those attending the meeting in person will be signed in on site and will vote at the conclusion of the meeting.

Procedures: In accordance with the Center for Spiritual Living Greater Las Vegas Bylaws, requiring that voting be done only in person, the voting for this Annual Meeting will be held via a drive-up ballot drop at the center. In order to maintain social distancing requirements, you are not to leave your car. Simply follow the designated signs and guidance of on-site volunteers. As per state policy, please wear a mask during the time you complete your ballot. Masks will also be made available for those who do not have one.
